



### Equine Activity Release and Hold Harmless Agreement for Riders

I, \_\_\_\_\_, the undersigned, have read and understand, and freely and voluntarily enter into this Release and Hold Harmless Agreement with Culpeper Battlefield Tours, LLC, understanding that this Release and Hold Harmless Agreement is a waiver of any and all liability(ies). My participation in this equine activity is purely voluntary, and I elect to participate in spite of and with full knowledge of the risks.
2. I understand the potential dangers that I could incur in mounting, riding, walking, leading horses; including, but not limited to, any interactions with other horses. Understanding those risks, I hereby release Culpeper Battlefield Tours, LLC, their successors and or assigns, employees, family members and anyone else directly or indirectly connected with them from any liability whatsoever in the event of injury, death or damage of any nature to me, my equipment or anyone else caused by or incidental to my electing to mount and ride a horse or participate in any other equine activity.

I understand and recognize and warrant that this Release and Hold Harmless Agreement is being voluntarily and intentionally signed and agreed to, and that in signing this Release and Hold Harmless agreement I know and understand this may further limit the liability of Culpeper Battlefield Tours, LLC and their equine professional(s), to include any activity, whatsoever, involving an equine, including death, personal injury and/or damage to property
4. I certify that I am fully capable of participating in this activity and do not need to be monitored by a Culpeper Battlefield Tours, LLC equine professional(s).

I further voluntarily agree and warrant to Release and Hold Harmless Culpeper Battlefield Tours, LLC and their equine professional(s) from any liability whatsoever, including, but not limited to, injuries, death or property damage to myself or my horse(s) or the horse I am riding from: interacting with; mounting; riding; dismounting; walking; grooming; feeding; use of trails in any capacity; falling off horse whether horse is bucking, flipping, spooked; or by failure related to my riding.

NOTICE: Wearing an ASTM approved/SEI certified helmet and approved riding boots is required while under direction of Culpeper Battlefield Tours, LLC and their equine professional(s) and while riding on their property. I understand this and if I were to choose not to wear or use this equipment, I will hold Culpeper Battlefield Tours, LLC harmless from any and all liability resulting from or by, not following this requirement.

**I HAVE CAREFULLY READ, AND CLEARLY UNDERSTAND AND ACCEPT THE TERMS AND CONDITIONS STATED HEREIN AND ACKNOWLEDGE THAT THIS AGREEMENT SHALL BE EFFECTIVE AND BINDING UPON MYSELF, MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVE AND ESTATE, AND FOR ALL MEMBERS OF MY FAMILY, INCLUDING ANY MINORS UNDER MY GUARD.**
